Proceedings:

- February meeting minutes were approved.

Treasurer's Report:

- **Kevin McCaffery** discussed the current balances of the league accounts:
 - Checking: \$5,556.74
 - Savings: \$3,305.02

VP Report / Trail Board:

- **Euan Davidson** presented a list of outstanding fees and fines to each manager.
- **Tim O'Donovan** is absent so all cards and referees reports are to be sent to **Bryan Card** for the next 2 weeks.

Scheduler's Report

- **Euan Davidson** asked the managers if we should eliminate the last round of games so that we can finish the league games before June.
- Two different scenario's were presented to managers (handout):
 - 3 Rounds for the Premiere Division, 2 Rounds for the First Division
 - 3 Rounds for the Premiere Division, 3 Rounds for the First Division
- There was much discussion about different scenarios including playing Saturday games and double headers. The following Motions were voted on and passed:
 - Premiere League to play 4 rounds – **PASSED**
 - Allow Euan to schedule Saturday games for Premiere only if necessary – **PASSED**.
 - First Division to play 3 rounds – **PASSED**
 - Allow Euan to schedule Saturday games for 1st Division only if necessary – **PASSED**.
- **Euan** asked managers if they would be willing to play games on Mothers Day (May 11th).
 - A paper was passed around for managers to sign up if they are willing to play.
 - **Euan** will ONLY schedule teams that have both agreed to play on Mothers Day.

New Business:

- **Bryan Card** asked managers to submit typed sign-in sheets for each game, not hand written.
- **Euan Davidson** advised that there have been complaints about referees.
 - All complains need to be directed to **Luis Gutierrez**, Referee Representative.
 - Please email complaints to Luis, do not contact Maggie, Referee Scheduler.
- **Andy Gillespie** inquired about what the league was doing to increase it's size.
 - Bryan Card is talking to other leagues and teams but nothing concrete has emerged.
- The Conejo Valley Parks and Recs Department has asked that TCSL send a letter confirming that we are a non-profit organization. **Bryan Card** agreed and will take care of it.
