### **Proceedings:**

- *Meeting called to order at 7:05 p.m. by President, Bryan Card.*
- March meeting minutes were approved.

### **Correspondence:**

- **Bryan Card** discussed issues with the referees:
  - Player cards and match reports have been misplaced / missing.

### **Scheduler's Report**

- **Euan Davidson** is not present but sends his appreciation to all managers for being flexible to schedule changes.

### **New Business:**

- **Bryan Card** cannot attend regularly scheduled league meetings and has moved them to the 2<sup>nd</sup> Wednesday of each month for the rest of the season.
- **Bryan Card** discussed the league's non-profit status.
  - TCSL had non-profit status from 1977 to 1983. It was then revoked because TCSL did not file IRS paperwork. Bryan is working on getting the non-profit status reinstated.
  - Non-Profit status will not allow teams to get cheaper fields. The individual clubs and / or teams must become non-profit for this benefit.
  - This will allow donations to be tax deductible.
- **Andy Gillespie** inquired about a limit on the number of games a team can forfeit before there are consequences. **Bryan Card** was not sure about the limit and would research it.
