Proceedings:

- *Meeting called to order at 7:48 PM by President, Joe Henderson.*
- February 9th meeting minutes were not available and not approved.

Treasurer's Report:

- **Kevin McCaffery** submitted the current balances of the league accounts:

League Notes:

- CSA South
 - Office still open and managers can still get cards for new players.
 - Only open Wednesday 5pm – 5:30pm to drop off information + \$20 fee.

- CalSouth
 - They are having their AGM in a few weeks.
 - Will get more information about registration and players' card's soon.
 - Teams in TCSL will be able to enter tournaments when we get CalSouth affiliation.
 - Joe Henderson has extra CalSouth information packets for any teams that did not receive one when they were here a few months ago.
 - If you did not receive one please speak with Joe.
- Player Behavior
 - There was an incident at a game where a player was red carded and asked to leave the field. He refused and continued to insult and threaten the referee from the parking lot.
 - Players threatening referees will not be tolerated and will be punished accordingly.
 - Alex Ghovanlo stated that the referees cannot make a player leave the parking lot.
 - Andy Gillespie said that the referees have every right to demand that the player leave the field and the parking lot. The player must be out of sight of the referee.
 - Jeff Plunkett (Ref. Assn.) stated that "California, and 2 other states, have laws that protect officials at games. You cannot threaten an official or there could be criminal prosecution."
- Ventura Community Park
 - Kelly Gray has pre-paid for field use and all teams playing at that field are required to pay him the appropriate field use fees.
 - There are a lot of teams that still owe Kelly Gray fees and those fees need to be paid in full immediately.
